Dear Office of the Registrar,

My name is Mashal Saif and I am an Assistant Professor of Religious Studies. I am writing on behalf of my department chair, Charlie Starkey, who is CCed in this email.

A Middle Eastern Studies Minor was recently started at Clemson. The minor (in its current form) requires students to take Arabic classes to get credit for the minor. Arabic instruction is currently being phased out at Clemson and we want students to have the option of taking of taking Arabic classes at nearby institutions as part of their Clemson curriculum. Greenville Tech offers Arabic classes and Furman did so in the recent past and might begin offering the language again. We are looking for a way for students to either (a) enroll seamlessly in these Arabic courses, or (b) be able to take the courses without incurring any additional tuition costs, and have the courses transfer in for Clemson credit.

Can you please let us know how to proceed in this regard.

Griffin convened the meeting at 1:30 PM

#### Introductions

Griffin welcomed the committee and opened the meeting with introductions.

#### Approval of minutes

The committee approved the November meeting minutes.

#### **New Business**

- **A.** A&H General Education Subcommittee (attached) Griffin reviewed the recommendations from Bruce Whisler, subcommittee chair, with the committee. Kosinski stated that the recommendation was too lean, and included no artifact examples. After further discussion, someone made a motion to accept the recommendation, all approved, no one opposed.
- B. Pass/No Pass Proposal LeDon Wilson Wilson stated that current pass/fail courses are difficult to police with the implementation of Banner. Since the Banner implementation in 2013, approximately 51 students have been tracked under the P/NP option. Committee members discussed when the new policy would be in effect, and Wilson responded that the new policy would take effect this fall and will be printed in the 2016-2017 Undergraduate Announcements. Griffin asked the Student Government representative for feedback. Mohan requested clarity as to why the change was needed now. Wilson stated the change is needed now for better efficiency of Banner.

Proposal: Delete the Pass/No Pass Option passage found in the Undergraduate Announcements with the statement shown below. (Currently printed on pages 27 and 28 in the 2015-2016 Undergraduate Announcements.)

After discussion, someone made a motion to accept the recommendation, all approved, no one opposed.

#### Old Business

**A.** Course and Curriculum Change System Update – Appling reported that the workflow system was ready for testing; however, CCIT hit a glitch and no one has been able to access the system.

- e. Science & Technology in Society Pam Mack Mack recommends adding CPSC 2920 as an accepted course for STS. She reported the course will come up later today. The committee approved pending course approval.
- f. Ethical Judgment Dan Wueste Wueste reported that the institute is piloting the Ethics system within CU1000 with the hope of engaging students. He stated there will be data from the current cohort, freshmen through senior year.

#### **Other Business**

Griffin stated that upon reviewing the curriculum with fresh eyes for the first time, he sees we have some work ahead. He reported that he hopes that this committee will decline any wording that states "see advisor". The list must be in Banner or it becomes impossible for the efficient use of Degree Works. He stated that he will be evaluating courses for prerequisites/corequisites, course numbering and learning outcomes.

Griffin reported the Provost would give him 12 months before this committee is expected to begin work with changes to General Education, but he is eager to work with the committee to develop a great General Education program that will meet the 2020 Forward challenge.

Griffin proposed making the agenda due date for the December meeting the Friday before Thanksgiving week. He encouraged the committee to provide feedback about Clemson Box use.

Tyminski asked about this meeting being the final meeting to make the Undergraduate Announcements. Blondeau reported that the Registrar is reviewing proposals that would not require the printing of the announcements, it would be available online.

The meeting adjourned at 4:14 PM.

The summer Gen Ed assessment team made the following recommendation:

 Arts and Humanities – The competency should be changed. Suggested competency –

Demonstrate an ability to analyze and/or interpret the arts and humanities as a reflection of human expression.

Or

Demonstrate an ability to analyze and/or interpret the arts and humanities as an expression of the human condition.

I believe the original competency presented to the UUCC some years ago was similar to those above. The UUCC thought that *human expression/condition* was too vague, so the competency was revised and approved as follows:

Demonstrate an understanding of the arts and humanities in historical and cultural contexts.

The wording above is the current arts & humanities competency. The A & H sub-committee has discussed the issue and we propose the following wording as the new A & H competency.

Demonstrate an ability to analyze and/or interpret the arts and humanities.
